As a result of this change the board decided to do a full review of the by-law. The following is a list of the changes the Board is recommending:

- All the changes have caused the numbering to change throughout the document.
- Add -DEFINITIONS
- Add In these By-Laws of the Society, unless the context otherwise requires, the following words shall have these meanings.
 - o Add Act means the Societies ACT R.S.A. 2000. c. S-14
 - o Add Board means the Board of Directors of this Society
 - Add Society means the Society for Safe and Caring Schools & Communities
 - o Add Officer means any Officer listed in Article 14.1
- MEMBERSHIP under this article the following changes were made
 - o Qualifications
 - Change SACSC office to the Society's office for approval.
 - Delete By doing so the Member is committing to the objects and principles of the Society.
 - o Rights of Members:
 - Delete under the Regulation passed (2.3 old number 3.3 new number)
- MEETINGS
 - Notice of Meeting
 - Change fax, email to electronic means
 - o Alternate Notice: Delete entire section
 - o Quorum
 - Change members from Fifteen (15) to Eighteen (18)
- CESSATION OF MEMBERSHIP
 - Resignation

 - Death Add or Dissolution
 - Add or the dissolution of the organization
- AUDITOR

- Delete one of whom shall be the immediate past president who shall be the chairperson of the committee and two of whom shall be chosen by majority vote at a general meeting. In the event that the Immediate Past President is not able to serve, some other person familiar with the affairs of the Society may be appointed by the Board to fill the position of the Immediate Past President on the Committee.

- DISSOLUTION OR WINDING-UP Capitalize to separate from DOCUMENTS and recognize as separate article
 - Change to one or more qualified donees as defined under the provisions of the Income Tax Act (Canada) having similar objects to as determined by the Board of Directors.
